### **ROBIX DEMONSTRATES OIL SPILL RECOVERY TECHNOLOGY TO MEXICAN GOVERNMENT AND PEMEX REPRESENTATIVES**

**July 8, 2015 – Lethbridge, AB: Robix Alternative Fuels, Inc. (“Robix” or the “Company”) (RZX:CSE, ROX:Frankfurt)** announced today that its Mexican subsidiary Corris Technologies Mexico S.A. de C.V. (Corris) is meeting with and providing a demonstration of its Clean Ocean Vessel oil spill recovery technology to Government officials from the State of Tabasco, Mexico, and senior representatives of Petroleos Mexicanos (Pemex) on July 8, 2015, in Villahermosa, Mexico. Corris is presenting jointly with Grupo Macomax S.A. de C.V. (see Robix press release dated March 27, 2015) and Petrolmeca S.A. de C.V. (see Robix press release dated May 4, 2015).

“This is a significant meeting for Robix, as it will be our first opportunity to demonstrate the technology which is used in the C Series products to important decision makers and stakeholders in Mexico,” commented Nathan Hansen, President and CEO of Robix. “I am pleased that we are seeing immediate traction on our newly formed relationships with Grupo Macomax and Petrolmeca, two very experienced and widely respected groups that were introduced to us by our Mexican consultants Alva, O’Driscoll & Asociados. Corris, Grupo Macomax and Petrolmeca have identified complementary services that they provide and the potential to work together to respond to the need for more efficient and effective oil spill recovery services in the State of Tabasco, Mexico.”

Tabasco is a significant oil producing region of Mexico and as such hosts a large system of petroleum bearing pipelines. Oil spill contamination of rivers resulting from punctured pipelines has become a recurring problem in this region. Robix and Corris believe that the C10 Clean Ocean Vessel is an ideal unit to service such rivers, as it is small and nimble and can easily maneuver to recover spilled petroleum.
